I have agreed to be a volunteer for Middle Waves Music Festival ("Festival"). In consideration of Middle Waves, Inc. ("Middle Waves") granting me permission to volunteer for the Festival, I agree as follows:

IMAGE RELEASE

I hereby grant Middle Waves and its contractors, consultants, and sponsors the right to record audio, photograph and/or film me at any and all times throughout the Festival and grant the rights to: (i) use all or part of my name, gender, age or other biographical facts, my image, likeness, and voice captured in such photographs and recordings, and in derivative works thereof, in perpetuity throughout the world; and (ii) edit, delete from, add to, use, and publish or broadcast such information, images, recordings, or portions thereof, at any future times on the radio, television, internet, mobile phones, and in any printed, electronic, or published materials as part of any Festival promotion or for any other purposes related to the Festival, Middle Waves, or the sponsors.

NO COMPENSATION

I further acknowledge and agree that no money or other consideration in any form, including reimbursement for any expenses incurred by me, will be due to me or anyone else at any time because of my participation in or attendance at the Festival or for the use of my biographical facts, image, appearance, likeness and/or voice as described above.

RELEASE AND INDEMNITY

I fully accept and assume any and all risks associated with my participation in the festival, including the full risk of any injuries, including death. I agree to accept full responsibility for and to waive and release Middle Waves, artists, producers, agents, and their affiliates, sponsors, and their respective successors, assigns, directors, officers, employees, agents, volunteers, partners and representatives (collectively, the "released parties") from and against any and all claims, as defined below, that I have or may ever have in the future against any of the released parties, relating to, arising out of or in connection with my participation in, or attendance at, the Festival, or the use of my biographical facts, image, appearance, likeness and/or voice. I shall indemnify, defend and hold harmless the released parties from any and all claims, as defined below, relating to, coming out of or in connection with my participation in, or attendance at, the Festival (including, without limitation, relating to medical expenses, the use of my image, appearance, likeness and/or voice and any other thing relating to or arising from such participation or attendance) and/or the terms of this release. As used in this release, "claims" means any and all actual or threatened claims, liabilities, demands, expenses, losses, damages, suits, judgments, awards, liens, settlements, penalties, fines, costs, expenses, attorneys' fees and liquidated, punitive or exemplary damages whatsoever of any nature. These waiver, release, and indemnification provisions include, without limitation: (i) all claims arising out of my injury or death or the injury or death any other person; (ii) all claims arising out of injury to or loss or destruction of any of my property or the property of any other person; (iii) all claims arising out of any of my acts or omissions, whether or not any such act or omission involves my negligence, gross negligence, or willful misconduct; (iv) any negligence of any of the released parties.
